## What is this product?

#### Type

BPER International SICAV is an undertaking for collective investment in transferable securities (UCITS) incorporated in the legal form of an investment company with variable capital (SICAV) under Part I of the Luxembourg 2010 Law on undertakings for collective investment.

#### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Obiectives

The Sub-Fund will invest at least 85% of its assets in Class I2 HEUR shares in Janus Henderson Horizon Fund – Global High Yield Bond Fund (the 'Master Fund'), a Sub-Fund of Janus Henderson Horizon Fund. On an ancillary basis, the Sub-Fund may also invest up to 15% of its assets in liquid instruments. The Master Fund aims to provide an income with the potential for capital growth over the long term. Performance target: To outperform the ICE BofAML Global High Yield Constrained Index (100% Hedged) by 1.75% per annum, before the deduction of charges, over any 5 year period. The Master Fund invests at least 80% of its assets in high yield (non-investment grade, equivalent to BB+ rated or lower) corporate bonds, in any country. The Master Fund may invest up to 20% of its net assets in contingent convertible bonds (CoCos). The Master Fund may also invest in other assets including bonds of other types from any issuer, cash and money market instruments. The investment manager may use derivatives (complex financial instruments), including total return swaps, with the aim of making investment gains in line with the Master Fund's objective, to reduce risk or to manage the Master Fund more efficiently. The Master Fund is actively managed with reference to the ICE BofAMLGlobal High Yield Constrained Index (100% Hedged), which is broadly representative of the bonds in which it may invest, as this forms the basis of the Master Fund's performance target. The investment manager has discretion to choose investments for the Master Fund with weightings different to the index or not in the index, but at times the Master Fund may hold investments similar to the index. The Sub-Fund's investment returns will be very similar to those of the Master Fund. This Sub-Fund promotes environmental and/or social characteristics but does not have a sustainable investment objective.

The income in respect of an accumulation share class is not distributed but is retained in the sub-fund.

# Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

# What happens if UBS Asset Management (Europe) S.A. is unable to pay out?
